The standard ISO 14001 prescribes the requirements relative to the implementation of an environmental management (EMS) which allows a body to define an environmental policy and objectives to improve its environmental performances.

This standard involves in particular:

- A Management commitment,
- The evaluation and control of the environmental impacts,
- An environmental policy,
- Objectives and action plan,
- The raising awareness and the training of the staff,
- A Management review.

Certification

The entity which makes a commitment, in a relevant way towards its environmental and organizational context, obtains a certificate for 3 years, delivered by an **accredited certification body**, such as ECOPASS.

ECOPASS is the **eco-certification body specialized** in the environmental certification ISO 14001.
